HALF YEARLY TAXATION UPDATES FOR ACCOUNTANTS IN BUSINESS

Speaker: Martyn Ingles BSc FCA CTA

A PRACTICAL TAX BRUSH-UP FOR RETURNERS

Speaker: Alexandra Durrant FCA

Objectives: This annual course is designed for accountants returning to the professional workplace after a career break, providing an overview of the principles of PAYE and NIC, VAT and corporation tax. This is not a detailed technical course. It will give the delegates the confidence required to say "I can do that" when returning to the workplace. The basic principles of the three topics will be covered, most of which will already have been learnt and understood by delegates but which may not have been used for some time. The course will cover the more practical aspects of each subject area.

Who should attend: Returners to the professional workplace, and "old stagers", who may be dealing with payroll, VAT returns and corporation tax computation work and who need to be brought up to date.

Topics:

- A review of RTI, PAYE and NIC procedures
- Update on tax rates, tax bands, NI thresholds and NI rates 2021/22
- Statutory payments update SSP, SMP, SAP, SPP and shared parental pay
- An update on benefits and expenses following recent changes
- Basic corporation tax computation and the disallowed items
- Capital allowances update, loss relief and R&D tax credit
- VAT, the registration and deregistration point, use of VAT schemes, MTD and VAT and the common pitfalls on reclaiming VAT

Speaker: Alexandra Durrant is a chartered accountant and runs the practice Alexandra Durrant Limited in East Grinstead. She provides audit, tax and accounting services to her clients, including payroll services and advice. Whilst a partner in a firm of chartered accountants in the City she was responsible for payroll operations, advising clients on PAYE and NI legislation and procedures and carrying out PAYE and NI health checks. She writes and lectures regularly on payroll matters.

AFTER BREXIT AND THE TRANSITION – THE NEW TAX ENVIRONMENT

Speaker: Jeremy Mindell BA (Hons) CTA CIPD

Objectives: The end of the transition period on 31 December 2020 will see significant divergence between the EU and the UK. This seminar informs advisers about the tax issues, which will become critical, once the UK is no longer part of the EU tax regime.

The EU has a significant impact on both direct and indirect taxation. The EU sets Customs policies through the application of the Common External Tariff. It provides the framework for VAT. Its powers in terms of Direct taxation are less well known although its State Aid powers affect both Income Tax and Corporation Tax. £320+VAT for 4 places or £740+VAT for 12 places i.e. as little as £61.67+VAT per place. A 25 place Maxiticket is also available to high volume users for £1470+VAT. 2020's prices have been frozen for 2021.

How long is my Flexiticket valid for?

Your Flexiticket is valid for up to 13 months e.g. if the first course booked takes place in March 2021 your ticket will start on 1 March 2021 and will expire on 31 March 2022. Places must be used on courses which take place within the validity period of the ticket.

Where are the courses held?

Throughout the South East, live online using Zoom and recorded online for Excel courses available via the website sesca.co.uk. Maps and directions are available at sesca.co.uk/venues.

Which courses is the ticket valid on?

All half and whole day courses in the South East, Southern and Thames Valley Flexiticket programmes, live online courses and recorded online Excel courses, subject to availability.

When should I buy my ticket?

You can book your ticket and reserve places at any time. We will not invoice you until the 1st of the month in which the first course you wish to attend takes place. Thus, you can ensure your places on popular courses well in advance.

Do I have to use the Flexiticket on 4, 12 or 25 different courses?

No. The ticket can be used by any number of individuals on any number of courses totalling either 4,12 or 25.

Do I have to be a South East, Southern or Thames Valley member to be eligible for the scheme?

You will not receive separate joining instructions for individual courses held at venues. You will be emailed individual course joining information for each online course booked two days before the course date.
